| <b>Purpose</b> of the processing   | <ul style="list-style-type: none"><li>• The NHS provides several national health screening programmes to detect diseases or conditions early such as cervical and breast cancer, aortic aneurysm and diabetes.</li><li>• The information is shared so that the correct people are invited for screening. This means those who are most at risk can be offered treatment.</li></ul>   |
| <b>Lawful basis</b> for processing   | The following sections of the GDPR allow us to contact patients for screening.<br><br>Article 6(1)(e) – ‘processing is necessary...in the exercise of official authority vested in the controller...’<br><br>Article 9(2)(h) – ‘processing is necessary for the purpose of preventative...medicine...the provision of health or social care or treatment or the management of health or social care systems and services...’ |

| <b>Data we get from other organisations</b>                        | We receive information about your health from other organisations who are involved in providing you with health and social care. For example, if you go to hospital for treatment or an operation the hospital will send us a letter to let us know what happens. This means your GP medical record is kept up-to date when you receive care from other parts of the health service.  |
